#### 6. Reports

6.1 Competitions Convenor

- KCC has requested that the 19-pt event become an event under CT umbrella and thereby included in the CT calendar of events. KCC will form a committee specifically to organise the event including deciding the format, sponsors and prize money.
- Due to insufficient entries, the 19-pt event has been cancelled for 2025. It is tentatively scheduled for January 2026. (Subsequent to this meeting KCC has resolved that the event will be scheduled to be held each year on the March Labour Day long weekend.)
- A letter from Steve Andrewartha has been circulated to SBCC members which proposes changes to the southern GC pennant. It is to be circulated to the relevant clubs, requesting a reply before 31 July.
- Graham Keating is to obtain information regarding the Australian U21 event which is to be played at SBCC in January 2026.

6.4 Northern delegate's report

- NE, SL, D and EL clubs attended an NRCC meeting in which the Hi-Lo event was reformatted to become a fun Mystery Doubles.
- A meeting of club handicappers is to be organised, to discuss inconsistencies in handicapping.

#### 6.5 Openshaw Shield 2025

The Treasurer advised that the balance of the Tas Event account is \$10,634.62 It was moved that the Northern Tasmania Croquet Centre be paid \$6000 from the above amount (consisting of \$300 for tea and coffee, \$1500 for loss of lawn fees, and a \$4200 ex gratia payment). The Treasurer advised that the profit/loss for the event will take account of *all* expenditure incurred in the running of the event, irrespective of source, for example, the full cost of web development and the purchase of the Billy Goat leaf sucker.
